We hereby report the following:

Following marking was painted body on drums of randomly inspected.

Packing:

The commodity was poured in the new metal drums with black appearance. Each drum had a lid in the top side. Amongst the Inspected drums, following average figures was obtained for their dimensions:

-So far as it could be checked, the drums lid not welded by oxy acetylene.

Sampling:

Sampling was performed during stuffing the cargo into containers at warehouse, (The number of selected according to ASTM D140M-09, Standard Practice for Sampling Bituminous Materials). Only top side of the drums were accessible for taking increment.

All drawn samples were mixed well and 4x1 litter Composite samples were prepared; distributed as follows:

-1x1 litter composite sample was dispatched to non SGS lab seal No. 639213.

-3x1 litter composite samples were retained by SGS for 90 days with SGS seal No. 639214, 639215 & 639216.
